The following Program Articulation Agreements have been made between:

The Program Articulation Agreements outlined hereafter are entered into in good faith by both colleges. The colleges undertake to co-operate to ensure that students on associated programs are afforded the most beneficial academic opportunity subject to adherence to the highest relevant academic standards.

Articles of Agreement:

- These Program Articulation Agreements are subject to review every five years from the date of signing by both parties, or to a review being sought by either college at any time.
- Additional individual Program Articulation Agreements may be added in numerical sequence at any time with the agreement of both parties.
- The existence of a Program Articulation Agreement does not constitute a placement offer on a program.
- All applicants must provide documentary evidence of having successfully achieved the specific requirements of a particular Program Articulation Agreement.
- The existence of a program description in any promotional material does not constitute a legal undertaking that that program, or program stage, will be available the following academic year.
- Either party may terminate the Program Articulation Agreements, or any individual agreement by giving the other institution at least six months advance written notice of its intention to do so.
- In the event of termination, approved Program Articulation Agreement(s) shall continue under the articles of this agreement to ensure that any student(s) enrolled on a program, or part of a program, are facilitated in successfully completing that program.

MTU Programme: Higher Certificate in Arts in Culinary Arts

Recommended Point of Entry

Graduates of the Culinary Business Operations Certificate program at North Island College are eligible to enter Year 2 of the Higher Certificate in Arts in Culinary Arts at MTU - Kerry. Students will complete this program in two semesters of study.

On successful completion of the Higher Certificate in Arts in Culinary Arts a student may progress to Year 3 of the Bachelor of Arts in Culinary Arts and acquire this qualification in one additional year.

Grade Requirements
